

PRIVACY POLICY AGREEMENT

Speaky App respects the privacy of its users and has developed this Privacy Policy to demonstrate its commitment to protecting your privacy.

This Privacy Policy agreement (this "*Privacy Policy*") constitutes an agreement between you ("*You*") and the developers of this app, ("*We*" or "*Us*") and governs your use of the Speaky application, as defined below. The Speaky application is referred to in this Privacy Policy and other agreements as "*Speaky App*" or "*Licensed App*" and all services and provided features as "*Services*".

By downloading, installing, and using Speaky, you acknowledge that you have read, understood, and agree to be bound by and comply with this Privacy Policy. If you do not agree to the terms and conditions of this Privacy Policy, you are not entitled to use Speaky App.

These privacy policies (the "Privacy Policy") are intended to describe for you, as an individual who is a user of Speaky App or any other online services, the information we collect, how that information may be used, with whom it may be shared, and your choices about such uses and disclosures. By using Speaky App and its Services, you are accepting the practices described in this Privacy Policy.

1. HOW WE COLLECT AND USE INFORMATION

We use the URLs you've added to Speaky App to operate, maintain, and provide to you the basic text extracting features and functionality of the Services. These URLs are not stored server-side.

2. SHARING OF YOUR INFORMATION

a. We never share your personal data with third parties outside the Speaky App and its group companies (including any parent, subsidiaries and affiliates) without your consent.

b. What happens in the event of a change of control: We may buy or sell/divest/transfer the Speaky App, or any combination of its products, services, assets and/or businesses. Your user information related to the Services may be among the items sold or otherwise transferred in these types of transactions.

c. Instances where we are required to share your information: We will disclose your information where required to do so by law or subpoena or if we reasonably believe that such action is necessary to (a) comply with the law and the reasonable requests of law enforcement ; (b) to enforce our Terms of Use or to protect the security or integrity of our Services ; and/or (c) to exercise or protect the rights, property, or personal safety of Speaky App, our Users or others.

3. HOW WE STORE AND PROTECT YOUR INFORMATION

a. Storage and Processing: Your information collected through the Services may be stored and processed in the United States or any other country in which Speaky App or its subsidiaries, affiliates or service providers maintain facilities. We may transfer information that we collect about you, to affiliated entities, or to other third parties across borders and from your country or jurisdiction to other countries or jurisdictions around the world. If you are located in the European Union or other regions with laws governing data collection and use that may differ from U.S. law, please note that we may transfer information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction, and you consent to the transfer of information to the U.S. or any other country in which Speaky App or its parent, subsidiaries, affiliates or service providers maintain facilities and the use and disclosure of information about you as described in this Privacy Policy.

b. Compromise of information: In the event that any information under our control is compromised as a result of a breach of security, We will take reasonable steps to investigate the situation and where appropriate, notify those individuals whose information may have been compromised and take other steps, in accordance with any applicable laws and regulations.
